



**KERSTEN COLLEGE FEES CONTRACT,

MONEY MATTERS – 2020 FEES (OFFICIAL, FINAL VERSION)

PLEASE TAKE NOTE: The below mentioned fees will remain constant until JUNE 2020, HOWEVER, due to inflationary pressures, **may** increase as from 1 JULY 2020, in which case the school will provide parents with a term's (2nd Term 2020) notice to that effect.

Our annual education fees is as follows:

GRADES R – 2 ZAR28 800.00 (Twenty eight thousand eight hundred Rand) payable at R2400.00 per month, in advance, payable for 12 months of the year, last payment due on or before 1 December 2020. For children **registered and/or attending** the school before 31 December 2019, first payment due on or before 2 January 2019.

GRADES 3 – 6 ZAR30 000.00 (Thirty thousand Rand) payable at R2500.00 per month, in advance, payable for 12 months of the year, last payment due on or before 1 December 2020. For children **registered and/or attending** the school before 31 December 2019, first payment due on or before 2 January 2019

GRADE 7 ZAR30 600.00 (Thirty thousand Six hundred Rand) payable at R2550.00 per month, in advance, payable for 12 months of the year, last payment due on or before 1 December 2020. For children **registered and/or attending** the school before 31 December 2019, first payment due on or before 2 January 2019.

Please note that a child registered during any date in a month, will be deemed to have enrolled from the 1st day of the month wherein enrolment takes place.

Biological brother(s) and/or sister(s).

Please note, fee for first child is per above stated fees. First brother or sister pays R200 less per month than stated above and any brothers or sisters thereafter pay a further R200 per month less.

Stationery/ toiletries/paper and incidentals, as well as Workbooks for 2020.

For a fee of R1800.00, and payable on 1 December 2019 for children attending Kersten College during 2019, the school provides the **use** of stationery, etc plus **workbooks** required as per discretion of Kersten College. The basic list of the stationery and workbooks will be posted on the website, www.kerstencollege.co.za. Some NEW items, however, are limited to a certain number for the year 2020 and parents/guardians may have to replace thereafter. As the school has not increased the cost from 2019, albeit the cost of stationery will have increased by suppliers, some stationery items may be deemed as second hand. No debate regarding stationery will be entered into. This stationery stays at school, and the parents are required to have enough stationery items at home in order for children to complete their homework. For **new** enrolments for **2020**, this full fee is payable together with the first month's school fees which is strictly payable before enrolment takes place. **Text books** must be purchased by the parents There will be no sharing of textbooks, (Learner books) and required books to be provided to the child within 1 week of enrolment to the specific grade, unless a parent is able to provide evidence within the first week of enrolment/or first week of new school academic year 2020, that the book/s have been ordered and may be out of stock temporarily.

Please note that should the school provide any book to the learner, for example, a reader, it must be protected in a book bag, specifically produced for that purpose and, unfortunately, should the book be lost, defaced or in any other way destroyed, example, spillage onto book, allowing for normal wear and tear, the parent will be charged with a fee of whatever amount it will cost to replace the book, the sum of which charge is at the sole discretion of Kersten College.

Registration Fee: Once off fee – non- refundable. This is payable for new enrolments, to secure a place at the school, subject to there being a space for the child in the grade requested and the school accepting the child. R1500.00 / child

NB Re-Registration/Admin. Fee to secure child's space for 2020: Not refundable, for learners enrolled and attending the school before 2020, payable by 1 July 2019. Should this be paid later than 1 July 2019 the school cannot guarantee a space will be available in 2020 as space will immediately be offered to a child on the waiting list for 2020. R1000.00/ child
Furthermore, account with the school to be at a zero balance as at 1 July 2019.

2020 Annual Education fee, attracts a discount of 8% if paid in full by end February 2020 and will NOT be subject to any inflationary fees, should the school feel this is required from 1 July 2020. However, January 2020 and February 2020 school fees still to be paid on time.

Please note first month's fees payable upon enrolment should enrolment take place AFTER 2 January 2020.

Late payment of fees and other charges if received in full, in advance after 1st, but paid by 7th even if written arrangements have been made to pay at this later stage, with the director. R100.00 per child

Monthly fees for Optional Aftercare until 18.00, provided on schooldays.

Light Lunch will be provided. No payment for December 2020.

Late payment of aftercare fees if received in advance, in full after 1st but By 7th. even if written arrangements have been made to pay between 2nd and 7th, with the director. Casual Aftercare charge is R50 per day, however casual is only acceptable if use of aftercare is no more than 2 days per week.

Should the abovementioned full fees plus late payment fees not be paid by close of business 7th monthly, in ADVANCE, a reminder letter at a cost of R50 payable together with the outstanding fees, will be sent by email approximately mid- month, to the person whose email address the school has listed on file, as well as the learner being provided with a hard copy statement to take home. Should the fees still not have been paid in full including the fees payable for the following month, by the last day of the said month, and no acceptable, in writing, arrangement made with the Director by the end of that particular month an Urgent Notice will be sent to the signatory (ies) to this contract which may result in the matter being reported as a default to the Credit Bureaus, and may result in the learner being de-registered from Kersten College. Please note too, that the signatories to this document, should there be more than one, are both jointly and severally responsible for all amounts payable and due to Kersten College.

The above decisions have not been made lightly. The school's **sole** income is derived from school fees (Tuition fees). Parents/Guardians need to regard school fees as a priority in order to enjoy the services the school provides.

Children are allocated to classes solely at the school's discretion. The school reserves the right to change, replace, and/or rotate all staff and/or to assign or reassign children to classes, without notice. It is the parents' responsibility to ensure that they are kept informed per e-mail on all matters pertaining to fees, including increases. Please note neither statement, nor receipts will be mailed on a monthly basis, albeit these are available upon request. Kindly contact the school Director regarding any payment/fees enquiries. All monies received are allocated at the school's discretion.
